

## Iridium OpenPort(R) Global Service Program in Operation Effective April 1

MCLEAN, Va., April 4, 2011 -- Iridium Communications Inc. (Nasdaq:IRDM) today announced the operational launch of its Global Service Program to support all customers of the Iridium OpenPort® broadband maritime satellite communication service, effective April 1.

The Iridium OpenPort Global Service Program will enable Iridium's Customer Care team to dispatch 24/7 shipboard technical support at more than 50 ports around the world. Iridium is the first mobile satellite service provider to offer full-service support of this kind for any of its products.
